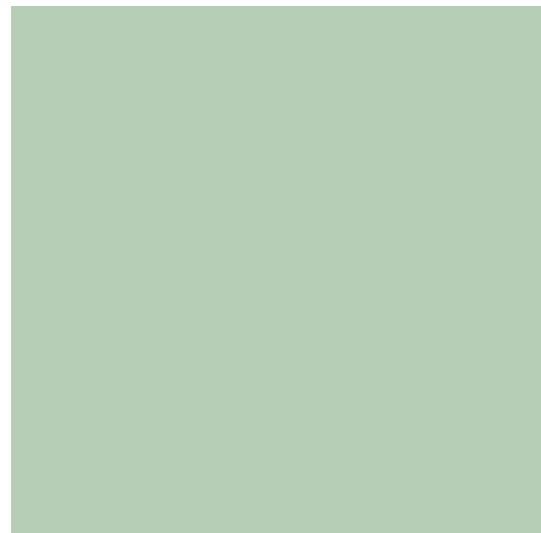


Personal mobility is increasing!

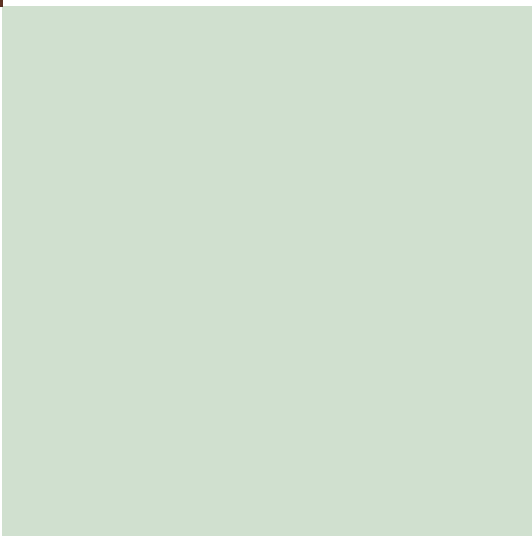

For information and questions about insurance coverage as well as claim handling, we have multilingual employees available during normal office hours.



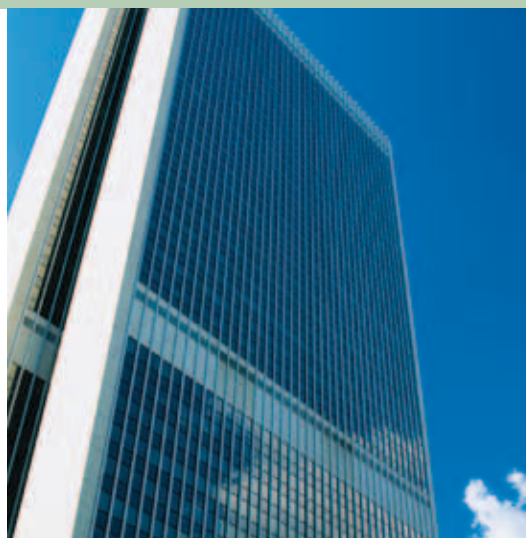
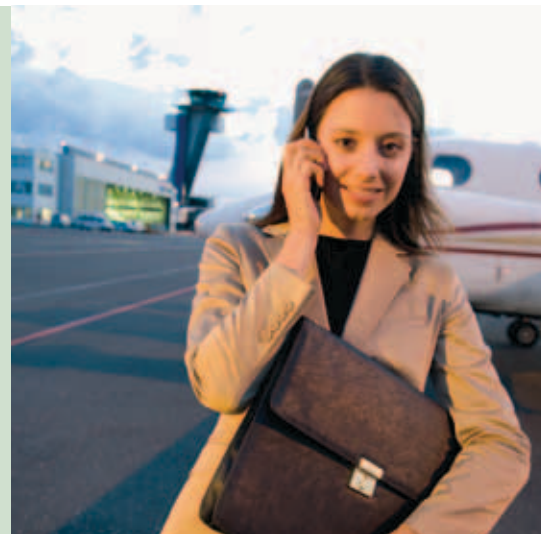

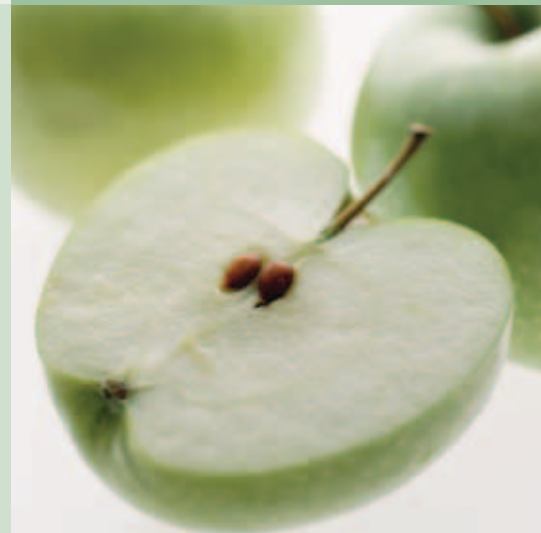
